
Dear Mr. Malcomson:

ORDINANCE NO. 67

ORDINANCE ANNEXING CERTAIN LANDS

TO THE VILLAGE OF STEWARTVILLE

WHEREAS, a petition for annexation of lands hereinafter described, duly signed by all of the owners of land, prepared for annexation has been filed with the Village Council of the Village of Stewartville;

AND WHEREAS, Copies of said petition have been filed with the Minnesota Municipal Commission, the High Forest Town Board, and the Olmsted County Board;

AND WHEREAS, more than thirty days have elapsed since filing copies of said petition with the Minnesota Municipal Commission, the High Forest Town Board and the Olmsted County Board, and no written objections to the proposed annexation have been filed with the Village of Stewartville;

AND WHEREAS, the Village Council of Stewartville, Minnesota, has determined that the annexation will be to the best interests of the Village of Stewartville and territory affected;

THE VILLAGE COUNCIL OF STEWARTVILLE, MINNESOTA, ORDAINS:

1. The following described lands are hereto annexed and made a part of the Village of Stewartville, to-wit: the South 1033 feet of the Southeast Quarter of the Southwest Quarter of Section 27, Township 105 North, Range 14 West, except the West 525 feet thereof and excepting the right-of-way of Trunk Highway Number 63 on the east side of said land. Containing approximately 15 acres more or less.

2. The Village Clerk shall file a certified copy of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.
