ORDINANCE NO. 67

ORDINANCE ANNEXING CERTAIN LANDS

TO THE VILLAGE OF STEWARTVILLE

WHERAS, a petition for annexation of lands hereinafter described, duly signed by all of the owners of land, prepared for annexation has been filled with the Village Council of the Village of Stewartville;

AND WHEREAS, Copies of said petition have been filed with the Minnesotat Municipal Commission, the High Forest Town Board, and the Olmsted County Board;

AND WHEREAS, more than thirty days have elapsed since filing copies of said petition with the Minnesota Municipal Commission, the High Forest Town Board and the Olmsted County Board, and no written objections to the proposed annexation have been filed with the Village of Stewartville;
