ORDINANCE NO. 68

ORDINANCE ANNEXING CERTAIN LANDS

TO THE VILLAGE OF STEWARTVILLE

WHEREAS, a petition for annexation of lands hereinafter described duly signed by all of the owners of land prepared for annexation has been filed with the Village Council of the Village of Stewartville;

AND WHEREAS, copies of said petition have been filed with the Minnesota Municipal Commission, the High Forest Town Board, and the Olmsted County Board;

AND WHEREAS, more than thirty days have elapsed since filing copies of said petition with the Minnesota Municipal Commission, the High Forest Town Board, and the Olmsted County Board, and no written objections to the proposed annexation have been filed with the Village of Stewartville;

AND WHEREAS, the Village Council of Stewartville, Minnesota, has determined that the annexation will be to the best interest of the Village of Stewartville and territory affected;

THE VILLAGE COUNCIL OF STEWARTVILLE, MINNESOTA ORDAINS:

1. The following described lands are hereto annexed and made a part of the Village of Stewartville, to-wit: A part of the Northwest Quarter of Section 2, Township 104 North, Range 14 West, described by metes and bounds as follows: Commencing at the northeast corner of said quarter section marked by a stone monument, thence west along the north line of said quarter section a distance of 500.37 feet to the northwest corner of Brin's Second Addition, Village of Stewartville, Minn; thence south at right angles along the west line of said Brin's Second Addition, 389.00 feet to the place of beginning; thence south along the west line of Brin's Second Addition and said line extended 1164.86 feet; thence West at right angles, 314.75 feet; thence north at right angles, 1164.86 feet; thence east at right angles 314.75 feet to the place of beginning. Containing in all, 8.42 acres.

2. The Village Clerk shall file a certified copy of this ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State,
