M., all members of the Commission being in attendance, relating to the annexation to the City of St. Cloud, Minnesota, of

CLOUD, MINNESOTA, according to the plat and survey of such Addition on file and of record in the office of the Register of Deeds in and for said Stearns County, Minnesota, and being more particularly described in the resolution, said annexation proceeding being based upon the petition of a majority of the owners of the said real estate platted into lots and blocks as Leeds Addition to St. Cloud, Minnesota, and pursuant to the provisions of Chapter 159, General Laws of Minnesota of 1919, approved April 2nd, 1919.

Considerioner Engagement presented the following resolution and moved its adaption, which motion was seconded by Commissioner Maybury:

THIREAS, a position in writing, duly verified, has been presented to this Commission by J. M. CLOUD, MINNESOTA, being the Mortherly two (3) sores of the North Half of the Southeast Quarter of the Southeast Quarter of the Northeast Quarter (No SE SE NE) of Section Nine (8), Township One hundred twentyfour (124), Range Twenty-eight (28) West, in Stearns County, Minnesota, and which property abute upon the corporate limits of the City of St. Cloud, Minnesota, an incorporated city having a population of not less than ten thousand people nor nore than twenty thousand people, according to the last federal commus- to have the above described real estate and property, constating of said lote and blooks comprising said Lee's Addition to St. Cloud, Minnesota, eforesaid, and all thereof, annexed to and made a part of the said City of St. Cloud, and brought within the cornerate limits. of said City of St. Cloud, Minnesota, and subjected to city government, and that without further notice to said petitioners. proper action in that behalf be taken so provided by law:

EOU, THEREFORE, BE IT RESOLVED by the City Commission of the City of St. Cloud, Minnesota, that said petition be, and the same hereby is in all things granted, and the above described and property, consisting of said real estate and property here-tofore platted into lots and blocks as NEE'S ADDITION TO ST. CLOUD, MINNESOTA, according to the plat and survey of said Addition on fileand of record in the office of the Register of Deeds in and for said County of Stearns and State of Minnesota, be, and the same hereby is, annexed to and brought within the

City of St. Cloud, Minnesota, and that the same is hereby declared to be an addition to caid City of St. Cloud, and a part of said City of St. Cloud, Minnesota, as effectually as if the said real estate and presides so constituing said platted Addition as aforesaid had been originally a part of said City of St. Cloud, Minnesota.

Bo it Further Resolved, that a certifical copy of this Resolution be duly filed and recorded in the effice of the Register of Deeds within and for said County of Stearns and State of Minnesota, the county wherein said territory thus amnexed is situated, and that a certified copy of said resolution be also filed in the effice of the County Auditor of the County of Stearns, and State of Minnesota, as required by the terms of Chapter 150, general Lass of Minnesota for 1919, as approved April 3nd, 1919.
