ORDINANCE No. 47

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ARLINGTON TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated June 30, 1967, requesting annexation of the territory hereinafter described was duly presented to the Council on the 3rd day of July, 1967; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 4.32 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all owners, and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the North boundary thereof;

The Common Council of the City of Arlington, Minnesota, does ordain:

Section 1. The City Council hereby determines (1) that the annexation will be to the best interests of the City and of the territory affected; (2) that the territory described herein abuts upon the City limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the City are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

Part of the Northwest Quarter (NW $\frac{1}{4}$ ) of Section Nine (9), Township One Hundred Thirteen (113) North of Range Twenty-seven (27) West, Sibley County, Minnesota, described as follows:

Commencing at the Northwest corner of Block 4 of Hilleman's Addition to the City of Arlington, Minnesota; Thence bearing north along the east line of 7th Avenue Northwest, 586.3 feet to the Northwest corner of the Arlington Municipal Hospital property as recorded in Book 45 of Deeds, page 443; Thence bearing North 88° 46' East along the North line of the said Arlington Municipal Hospital property, 400 feet; thence bearing North 0° 09' East, 35 feet to the point of beginning of the following described tract; thence bearing North 0° 09' East along the East line of the St. Mary's Church property, 339.5 feet; thence bearing North 88° 46' East, 570.63 feet; thence bearing South 0° 09' West, 339.5 feet to a point 35 feet North of the Easterly projection of the North line of the Arlington Municipal Hospital property; thence bearing South 88° 46' West, 570.63 feet to the point of beginning, excepting therefrom that part lying within the right-of-way of Minnesota Trunk Highway No. 5 and containing 4.32 acres of land more or less.

Section 3. Filing. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 4. Effective Date of Annexation. This ordinance takes effect thirty days after its passage and publication and the filing of certified copies as directed in Section 3.
