ORDINANCE No. 295

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON AND ANNEXING THERETO CERTAIN UNPLATTED LAND FORMERLY LOCATED IN THE TOWNSHIP OF ACOMA.

Section 1. A petition has been filed with the governing body of the City of Hutchinson, Minnesota, by Eldred Miller and Rosetta Miller, being the owners of the following described real estate, to have said property annexed and included within the corporate limits of the City of Hutchinson, County of McLeod, State of Minnesota, to-wit:

Commencing at the Northeast Corner of the Southeast Quarter of Section 36, Township 117 North, Range 30 West; thence Southerly along the East line of said Southeast Quarter of Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$) a distance of 244.0 feet to the point of beginning of the tract herein described, the same being a point on the Northerly 75 foot Right-of-Way line of Minnesota Trunk Highway No. 22; thence continuing Westerly along said Right-of-Way line 100 feet; thence Northerly on a line parallel to the East line of said Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$), a distance of 200 feet; thence continuing Easterly to a point on the East line of the said Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$), said point being 200 feet North of the point of beginning of the tract herein described; thence Southerly along the East line of said Southeast Quarter of the Southwest Quarter (SE $\frac{1}{4}$ of SW $\frac{1}{4}$), a distance of 200 feet to the point of beginning. The above described land being a part of the South. One-Half (S $\frac{1}{2}$) and the Southwest Quarter (SW $\frac{1}{4}$) of Section 36, Township 117 North, Range 30 West.

Section 2. The quantity of land embraced within the foregoing description, and bound as described, is less than 200 acres.

Section 3. The City Council hereby determines: (1) that the annexation will be to the best interests of the City of Hutchinson, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section 4. Therefore, the City of Hutchinson, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
