

CERTIFIED COPY OF RESOLUTION.

The following resolution was unanimously adopted by the City Commission of the City of St. Cloud, Minnesota, at a duly called Special Meeting of the said City Commission of the City of St. Cloud, held on the 26th day of April, 1910, at two o'clock P. M., all members of the Commission being in attendance, relating to the annexation to the City of St. Cloud, Minnesota, of COTTAGE PLACE ADDITION TO ST. CLOUD, MINNESOTA, and SCHROEDER'S ACRE LOTS AND ADDITION TO ST. CLOUD, MINNESOTA, according to the respective plats of said Additions on file and of record in the office of the Register of Deeds in and for said Stearns County, Minnesota, and said property being situated in the County of Stearns and State of Minnesota, and being especially particularly described in said resolution, said annexation proceeding being based upon the separate petitions of a majority of the owners of the said real estate platted into lots and blocks, respectively, of said Cottage Place Addition to St. Cloud, Minnesota, and Schroeder's Acre Lots and Addition to St. Cloud, Minnesota, and pursuant to the provisions of Chapter 150, General Laws of Minnesota of 1910, approved April 2nd, 1910.

Commissioner Magruder presented the following resolution and moved its adoption, which motion was seconded by Commissioner Maybury:

WHEREAS, a petition in writing, duly verified, has been presented to this Commission by A. G. Tritney, and others, being a majority of the owners of the real estate platted into lots and blocks as COTTAGE PLACE ADDITION TO ST. CLOUD, MINNESOTA, being the Northwest Quarter of the Northeast Quarter (NE<sup>1</sup>/4 NE<sup>1</sup>/4) of Section Sixteen (16), Township One hundred forty-four (144), Range Twenty-eight (28), in Stearns County, Minnesota, and which plat of said addition is on file and of record in the office of the Register of Deeds within and for said Stearns County, Minnesota, and which property lies upon the corporate limits of the City of St. Cloud, Minnesota, an incorporated city having a population of not less than ten thousand people nor more than twenty thousand people, according to the last federal census, to have the above described real estate and property, consisting of said lots and blocks comprising said Cottage Place Addition to St. Cloud, Minnesota, aforesaid, and all thereof, annexed to and made a part of the said City of St. Cloud, and brought within the corporate limits of said City of St. Cloud, and subjected to city government and that without further notice to said petitioners, proper action in that behalf be taken as provided by law; and

WHEREAS, a petition in writing, duly verified, has been presented to this Commission by S. C. Pandolfo, the majority owner of the real estate platted into acre lots or outlots as SCHROEDER'S ACRE LOTS AND ADDITION TO ST. CLOUD, MINNESOTA, according to the plat and survey thereof on file and of record in the office of the Register of Deeds in and for Stearns County,

Minnesota, said addition being platted upon the Southwest Quarter of the Southeast Quarter (sec 8a) of Section Nine (9), Township One hundred twenty-four (124), Range Twenty-eight (28), same and except that part occupied by railroad right of way, and situated in said Stearns County, Minnesota, and which property abuts upon the corporate limits of the City of St. Cloud, an incorporated city having the population as hereinbefore stated, to have the tract above described real estate and property, consisting of said acre lots and outlets comprising said Schroeder's Acre Lots and Addition to St. Cloud, Minnesota, aforesaid, and all thereof, annexed to and made a part of the said City of St. Cloud, and brought within the corporate limits of said City of St. Cloud, and subjected to city government, and without further notice to said petitioner, that proper action in that behalf be taken as provided by law:

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of St. Cloud, Minnesota, that said petitions are, and each of them is, hereby in all things granted, and the above described real estate and property hereinbefore platted into lots and blocks, or acre lots or outlets, as hereinbefore specified, as

COTTAGE PLACE ADDITION TO ST. CLOUD, MINNESOTA, and

SCHROEDER'S ACRE LOTS AND ADDITION TO ST. CLOUD, MINNESOTA, according to the respective plats and surveys of each of said additions, on file and of record in the office of the Register of Deeds in and for the said County of Stearns and State of Minnesota, and all thereof, and each and all of the lots and blocks of each and all thereof, as shown by the respective plats hereinbefore referred to, be, and the same hereby are, annexed to and brought within the City of St. Cloud, and that the same are, and each of them is hereby declared to be an addition to said City of St. Cloud,

and a part of said City of St. Cloud, Minnesota, as effectually  
as if the said real estate and premises be constituting said  
platted addition as aforesaid had been originally a part of  
said City of St. Cloud, Minnesota.

BE IT FURTHER RESOLVED, That a certified copy of this  
Resolution be duly filed and recorded in the office of the Register  
of Deeds within and for the County of Stearns and State of Minnesota,  
the county wherein said territory thus annexed is situated, and that  
a certified copy of said resolution be also filed in the office of  
the County Auditor of the County of Stearns and State of Minnesota,  
as required by the terms of Chapter 163, Section 1av of 1818, of  
the State of Minnesota, as approved April 11th, 1818.

Upon the roll being called, the Commissioners who voted  
in favor of the resolution were: Imperial, Magnuson and Keybury.  
Those opposed: None. And so the resolution was unanimously  
adopted, and was so declared by the chair.
