To PAUL A. LAVALLEE,

WHEREAS, The Legislature of the State of Minnesota, by Chapter 462 of the Laws of Minnesota for the year 1919, Sub-Divisions 7 and 8 thereof, appropriated the sum of Twenty-five Hundred and Fifty Dollars for the distribution of the Minnesota Digest and made the same available for the year ending July 31st, 1920, and further appropriated the sum of Eighteen Hundred Dollars for the distribution of the Minnesota Digest and made the same available for the year ending July 31st, 1921, and it was contemplated by the Legislature thereby that there should be delivered to each of the officials of the State of Minnesota, and of the Counties, Cities and Villages of the State, whose titles appear upon the list hereto attached, marked Exhibit "A" and hereby made a part hereof, the Minnesota Quarterly Digest covering the Minnesota Reports from Volume 130 to Volume 138, known as K.D. Volume I, and that during the fiscal years of 1919-1920, 1920-1921, there should also be delivered to each of said officials the Minnesota Quarterly Digest, thereby bringing the Minnesota Digest down to date and thereafter maintaining the same;

NOW, THEREFORE, For the purpose of giving effect to said Act and as a Warrant to you in carrying out the same, you are hereby authorized and directed to deliver, forthwith, to each of the officials named in said List "A":

1. One copy of the Minnesota Digest, being the biennial bound volume of the Minnesota quarterly Cumulative Digest, otherwise known as K.D. Volume I, covering Minnesota Reports, Volumes 130 to 138;

2. The Minnesota Quarterly Cumulative Digest
to and including July 31st, 1921.

And it is further directed, that vouchers for the
payment of all sums of money due you under the terms of said
Act and this Order shall be presented to the Secretary of
State of the State of Minnesota, to be approved by him before
presentation to the State Treasurer of said State, and that,
at the time of such approval as a condition precedent thereto,
there shall be attached to each such voucher the respective
receipts of the several officials for each delivery made in
accordance with the terms of the foregoing Order and Warrant.


