AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF HUTCHINSON, McLEOD COUNTY, MINNESOTA

(Hospital land)

THE CITY OF HUTCHINSON DOES ORDAIN:

Section I.

WHEREAS, the City of Hutchinson is the owner of the following described lands lying and being in the County of McLeod and State of Minnesota and described as follows, to-wit:

All that part of Lots 16 and 18 of Auditor's Plat of Section 7, Township 116 North, Range 29 West according to the plat thereof on file and of record in the Office of the Register of Deeds of McLeod County, Minnesota, described by metes and bounds as follows:

Section II.

Section III.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Hutchinson that the lands described above be and they hereby are annexed to the City of Hutchinson and from and after the date of passage of this Ordinance, said lands shall become a part and portion of the City of Hutchinson with the same force and effect as though originally a part of the city.

Section IV.

This Ordinance shall take effect and be in force from and after its publication.
