ORDINANCE NO. 368

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF WASECA,
MINNESOTA

THE COMMON COUNCIL OF THE CITY OF WASECA DOES ORDAIN:

Whereas, Grace Baptist Church has petitioned the common council of the city of Waseca to annex to said city the following described real estate in the county of Waseca, state of Minnesota, to-wit:

Commencing at a point Four Hundred (400) feet north of the south quarter corner, Section Seventeen (17), Township One Hundred Seven (107), Range Twenty-two (22) West; thence North Two Hundred (200) feet along the center line of the road; thence East Two Hundred Thirty-three (233) feet; thence South Two Hundred (200) feet; thence West Two Hundred Thirty-three (233) feet to the place of beginning, containing 1.07 acres, more or less.

And, whereas, it has been shown that said real estate is unplatted land of an area of less than 200 acres, that it is urban in character, that Grace Baptist Church of Waseca, Minnesota is the sole owner thereof, and that said property is contiguous to the city of Waseca and abuts on 8th Street S.E. of said city, and that it is in the best interest of the city of Waseca and of the territory affected that said described property be annexed to and made a part of the city of Waseca, a Municipal Corporation; and it having been shown that the Town Board of Woodville Township and the County Commissioners of the County of Waseca, in which Township and County said land is situated, have no objection to said proposed annexation and have waived the notice provision provided by Minnesota Statute Section 414.03,

NOW, THEREFORE, be it ordained by the common council of the city of Waseca, Minnesota, pursuant to the authority and provisions of Minnesota Statute Section 414.03:

Sec. 1

That said above described real estate be and the same hereby is annexed to the city of Waseca, Minnesota.

Sec. 2

That a duly certified copy of this ordinance shall be filed with

Minnesota Municipalities Commission, the Waseca County Auditor,
the Secretary of the State of Minnesota; and that a duly certified
copy of this ordinance be filed and recorded in the office of the
Register of Deeds of Waseca County, Minnesota.

Sec. 3

that this ordinance shall take effect and be in force from and
after the date of its publication in accordance with law.
