Ordinance No. 228 (New Series)
City of Blue Earth

An Ordinance Annexing Certain Real Estate to the City of Blue Earth, Minnesota

Be it Ordained by the City Council of the City of Blue Earth as follows:

Section I.

The following described real estate located in the County of Faribault and State of Minnesota, to-wit:

The East Half of the Northeast Quarter (E 1/2 of NE 1/4) of Section Nineteen (19) in Township One Hundred Two (102) North of Range Twenty-seven (27) West of the Fifth Principal Meridian in Faribault County, Minnesota excepting therefrom the following:

- (a) That portion thereof lying North of the Blue Earth River;
- (b) That portion thereof lying South of County-State Highway No. 6;
- (c) A tract of land commencing at the Southwest Corner of the Northeast Quarter of Section Nineteen (19), thence North 90 degrees - 00 minutes East along the South Line of the Northeast Quarter of Section Nineteen (19) (said line also being the centerline of County-State Aid Highway No. 6) a distance of 1130.8 feet, thence North 57 degrees - 58 minutes East a distance of 223.2 feet to the point of beginning on the West Line of the East Half of the Northeast Quarter of Section Nineteen (19), thence continuing North 57 degrees - 58 minutes East a distance of 175.0 feet, thence North 1 degree - 16 minutes East a distance of 369.5 feet, thence North 89 degrees - 01 minutes West a distance of 148.4 feet to the West Line of the East Half of the Northeast Quarter of Section Nineteen (19), thence South along the West Line of the East Half of the Northeast Quarter of Section Nineteen (19) a distance of 462.2 feet to the point of beginning.

hereby is annexed to the City of Blue Earth, a municipal corporation, in Faribault County, Minnesota and shall after the effective date of this ordinance be included in the corporate limits of said City.

Section II.

It is found by the City Council of the City of Blue Earth that annexation is in the best interests of said City and of the territory being annexed under this ordinance.

Section III.

It is further found that the petition for said annexation has been filed

in the manner provided by law and that no objections thereto have been filed.

Section IV.

It is further provided herein that the City Clerk of the City of Blue Earth shall file copies of this ordinance after publication with the Secretary of State of the State of Minnesota, with the Municipal Commission of the State of Minnesota and with the County Auditor of the County of Faribault.

Section V.

This ordinance shall be effective from and after its passage and publication as required by law.

Passed and adopted by the City Council of the City of Blue Earth, Minnesota this 18th day of June, 1968.
