ORDINANCE NO. 261

AN ORDINANCE RELATING TO THE ANNEXATION OF CERTAIN PROPERTY IN THE CITY OF ALEXANDRIA, MINNESOTA, DECLARING THE WARD TO WHICH IT SHALL BE ATTACHED AND EXTENDING THE CORPORATE LIMITS TO ENCOMPASS SAID LAND.

WHEREAS, Independent School District No. 206 has filed with the City Council a petition requesting that the hereinafter described property lying in the County of Douglas' and State of Minnesota, be annexed to the City of Alexandria, and further requesting that the corporate limits of the City of Alexandria be altered to include said property, and

WHEREAS, the governing body of the City of Alexandria has examined said petition and has found that Independent School District No. 206 is the sole owner of said property; that said property is contiguous to the existing boundaries of the City of Alexandria; and that said land is agricultural and contains no population, and

WHEREAS, the governing body of the City of Alexandria has caused copies of said annexation petition to be sent to the Alexandria Town Board, the Douglas County Auditor, and the Minnesota Municipal Commission and that no objection to said annexation has been received from any of said parties within thirty (30) days of notification, and

WHEREAS, the governing body of the City of Alexandria finds that the property set forth in said petition is so conditioned as to properly be subject to municipal government and further that the governing body of the City of Alexandria finds that the annexation of said property would be in the best interests of the municipality, and the territory affected and to be annexed,

NOW, THEREFORE, the City Council of the City of Alexandria does ordain:

SECTION I. That the following described land, to-wit:

A part of the Northeast Quarter (NE_{4}^{4}) , Section 30, Township 128, North, Range 37 West, and more particularly described as follows, to-wit: To find the point of beginning, commence at the Northeast corner of said Section 30; thence South 88° 40' West 1485.2 feet; thence South 1° 20' East 736.2 feet to the point of beginning; thence from the point of beginning South 1° 20' East 1704. feet to an iron monument; thence North 88° 40' East 1184.38 feet to an iron monument; thence North 1° 20' West 1704 feet; thence South 88° 40' West 1184.38 feet to the point of beginning and containing 46.35 acres more or less,

is hereby annexed to and made a part of the municipality of the City of Alexandria, Minnesota, and the corporate limits of the City of Alexandria, Minnesota, shall be and hereby are

AORRIS A. GROVER Attorney at Law 527/2 Broadway Lexandria. Minnesota 56308 extended to include and encompass the land and territory above described.

SECTION II. All of the land and territory described in Section I above, and hereby annexed to and made a part of the City of Alexandria, Minnesota, shall be and does hereby become a part of the Fourth Ward of the City of Alexandria.

SECTION III. This ordinance shall take effect from and after its passage and publication, in accordance with the laws of the State of Minnesota, the Charter of the City of Alexandria, and upon the filing of this Ordinance with the Minnesota Municipal Commission, the County Auditor of Douglas County, Minnesota, and the Secretary of State of the State of Minnesota.
