ORDINANCE NO. 589

ORDINANCE ANNEXING CERTAIN
LAND TO THE CITY OF ST. CLOUD

WHEREAS, St. Joseph's Home, being the owner of a certain tract of land described below, situated in Haven Township, Sherburne County, Minnesota, has filed a petition with the City and presented said petition to the Council requesting that that certain tract of land described below be annexed to the City of St. Cloud and made a part thereof, and

WHEREAS, after due and careful investigation and consideration, it is hereby found, determined and declared:

1. That said tract of land abuts and adjoins the present corporate limits of the City of St. Cloud, and that no part lies within or abuts on any other municipality.
2. That said petitioner is the sole owner of said tract of land; that said tract contains 90.44 acres, all of which is unplatted.
3. That there are no persons residing on said tract.
4. That the interests of the City of St. Cloud, and its inhabitants, and of the petitioner, will be best served by annexation of said tract of land to the City of St. Cloud.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ST. CLOUD HEREBY ORDAINS THAT the following described tract of land be, and the same hereby is, annexed to the City of St. Cloud, Minnesota, and declared to be a part thereof:

The SE $\frac{1}{4}$ NE $\frac{1}{4}$, Sec. 12, T 35N, R 31 W containing 40 acres, more or less, and

the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Sec. 12, T 35N, R 31 W containing 40 acres, more or less, and


those portions of lots 2 & 3, Sec. 12, T 35N, R 31 W, lying easterly of old Clear Lake Road, more particularly described as follows: Commencing at the N.E. corner of lot 2; thence south 40 ch. to the S.E. corner lot 3, which is the east R.O.W. line of the old Clear Lake Road; thence north 6°58' west along the said east R.O.W. line 20.15 ch.; thence north 8°55'W along said R.O.W. line 20.25 ch.; thence east along the north line lot 2 5.58 ch. to the point of beginning; containing 2.44 acres, more or less in lot 3, and 8.0 acres, more or less in lot 2.


