Ordinance No. 367

AN ORDINANCE EXTENDING THE CORPORATE LIMITS  
OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN  
LANDS ADJUTING UPON THE CITY LIMITS.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the council on the 1st day of April, 1968; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 0.41 of an acre of platted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by Evelyn Knobloch, the owner of the premises therein described; and

WHEREAS, no objections to the annexation have been received from the town board, the county board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the Westerly boundary thereof;

The City of Montevideo does ordain:

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Lot Eight (8) in Block Four (4) or Ira B. Wolfe's Second Subdivision of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$  of SE $\frac{1}{4}$ ) of Section Six (6), Township One Hundred Seventeen (117), Range Forty (40), Chippewa County, Minnesota, containing 0.41 of an acre of land.

Section 3. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

PETITION FOR ANNEXATION

TO THE CITY COUNCIL OF THE CITY OF MONTEVIDEO, MINNESOTA:

The undersigned, being the sole owner of the territory described below, hereby requests the council to annex this territory to the City and to extend the city boundaries to include the same, and for that purpose respectfully states:

1. The territory to be annexed consists entirely of land which is unplatted and is less than ten (10) acres in area. All of this land lies entirely within the County of Chippewa, Minnesota, and the description of such land is as follows:

A parcel of land in the Southeast Quarter (SE $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West, described as follows: Beginning at a point of intersection of a line that is parallel to and five hundred (500) feet South of the South line of Windom Avenue extended East as now platted in Kohr's First Addition to the City of Montevideo with the East line of the Southwest Quarter (SW $\frac{1}{4}$ ) of said Section Eight (8); thence West along a line that is parallel to and Five Hundred (500) feet south of the South line of said Windom Avenue extended a distance of Four Hundred Eighteen and Three-tenths (418.3) feet; thence South on a line with an internal angle of Eighty-nine Degrees Fifty-eight Minutes (89°58') and parallel to the East line of 13th Street as now platted in said Kohr's First Addition to a point of intersection with the Northerly right-of-way line of T. H. #7 as now located across said Southeast Quarter (SE $\frac{1}{4}$ ) of the Southwest Quarter (SW $\frac{1}{4}$ ); thence Southeasterly along said Northerly right-of-way line to the intersection with the East line of the Southwest Quarter (SW $\frac{1}{4}$ ) of said Section Eight (8); thence North along the East line of said Southwest Quarter (SW $\frac{1}{4}$ ) to the point of beginning.

2. The territory described above abuts upon the city limits at the northeasterly boundary thereof and none of it is presently included within the corporate limits of any incorporated city, village or borough.

3. All of this territory is or is about to become urban or suburban in character.
