ORDINANCE NO. 1447

AN ORDINANCE Annexing to the City of Rochester, Minnesota, Certain Unplatted Land Not Exceeding Two Hundred Acres in Area in the East One-Half of Section-Twelve, Township One Hundred Six, Range Fourteen, and Certain Platted Land in North Sunny Siopes, Olmsted County, Minnesota.

The Common Council of the City of Rochester do ordain:
Section 1. A petition has been filled with the Common Council of the City of Rochester, signed by all the owners of the Lands described herein, requesting the Common Council to annex said lands to the City of Rochester. The lands described in said pelition for annexation are located in Rochester Township, Olmsted County, Minnesota, and are described as follows:

Beginning at a point in the Southerscribed in said pelition for annexation are located in Rochester Township. Olmsted County, Minnesota, and are described as follows:

Beglinning at a point in the Southerly line of Outlot No. 6 in Meadow Park First Subdivision, where said line intersects the Easterly end of 16th Street Southeast, as platfed and dedicated in said Subdivision; thence Northeasterly along the south line of said Outlot No. 6 a distance of 329.6 feet, thence Southeasterly at a deflection angle of 99 degrees 34 minutes 45 seconds to the right a distance of 1006.73 feet; thence Southeasterly at right angles a distance of 375.00 feet to the centerline of County State Ald Highway No. 1; thence Northwesterly at right angles along the centerline of County State Ald Highway No. 1 a distance of 226.14 feet; thence Northwesterly at right angles along the centerline of County State Ald Highway No. 1 a distance of 226.14 feet; thence Northwesterly at right angles along the centerline of County State Ald Highway No. 1 as platted in Meadow Park First Subdivision; thence 'Northwesterly along a line lyling parallel to and 50.0 feet Easterly of the centerline of County State Ald Highway No. 1 feet Easterly of the centerline of County State Ald Highway No. 1 feet Easterly of the centerline of County State Ald Highway No. 1 for a distance of 725.74 feet to the place of beginning.

Section 2. The quantity of unplatted land described in Section 1 above is approximately 7.66 acres.

Section 3. The Common Council of the City of Rochester do hereby determine that the lands described in Section 1 above is approximately 7.66 acres.

Section 4. Therefore, the lands described in Section 1 above are hereby annexed, added to and made a part of the government, and the dest interests of the lands will be in the best interests of the City of Rochester and of the lands described in Section 1 above are hereby annexed, added to and made a part of the City of Rochester, Minnesota, as effectually as if they had originally been a part thereof.

Section 5. Present and future owners of the area annexed by this ordinance are hereby notified that in addition to the usual assessments, it is the intention of the Common Council to assess against benefited property all or a portion of the cost of any storm sewer, water tower and truth line sanitary sewer construction, hereforer or hereafter, undertaken to serve the area annexed.

Section 6. Present and future owners of the area annexed by this ordinance are hereby notified that by such annexation, the City of Rochester does not commit itself to extend its services and make local improvements in the area annexed on an assessment basis; and that the City of Rochester, through its Common Council, specifically reserves the right to annex additional area to the City of Rochester, nd. extend City services and make local improvements to such other later annexed areas in advance of improvements to the city of Rochester, through its common council, specifically reserves the right to annex additional area to the City of Rochester nd. extend City services and make local improvements to such other later annexed areas in advance of improvements to the city of Rochester, dect and be in force from and after its official publication and from and after the filling of a certified copy hereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State.
