CHAPTER XV

ORDINANCE NO. 190 - G

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF SARTELL TO INCLUDE UNINCORPORATED PROPERTY ADJUTING UPON THE VILLAGE LIMITS AND NOT EXCEEDING 200 ACRES IN AREA.

WHEREAS a certain petition requesting annexation of the territory hereinafter described was duly presented to the Village of Sartell on the 20th day of May, 1968; and,

WHEREAS the quantity of land embraced within the area described in the petition and bounded as described, is not in excess of 200 acres of unplatted land, and no part of which is included within the limits of an incorporated city, village or borough; and,

WHEREAS the petition was signed by all of the owners of said land; and,

WHEREAS no objections to the annexation have been received from the Town Board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and,

WHEREAS the land described in the petition abuts upon the Village limits on the Northerly side thereof, NOW, THEREFORE

THE COUNCIL OF THE VILLAGE OF SARTELL, MINNESOTA, ORDAINS AS FOLLOWS:

Subsection 1. The Village Council hereby determines that the annexation will be to the best interest of the Village and of the territory affected; that the territory described herein abuts upon the Village Limits and is about to become urban or suburban in character; and, that none of said territory is now included within the limits of any City, Village or Borough.

Subsection 2. Territory Annexed. The corporate limits of the village of Sartell are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the Village as effectually as if it had originally been a part thereof, to-wit:

"The Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$  SW $\frac{1}{4}$ ); The West One-Half of Northwest Quarter of Southwest Quarter (W $\frac{1}{2}$  NW $\frac{1}{4}$  SW $\frac{1}{4}$ ) all in Section Sixteen (16), Township One Hundred Twenty-Five (125) North, Range Twenty-Eight (28) West, Stearns County, Minnesota, containing 60 acres, more or less;  
The Northeast Quarter of Northeast Quarter (NE $\frac{1}{4}$  NE $\frac{1}{4}$ ) of Section Twenty (20), Township One Hundred Twenty-Five (125) North, Range Twenty-Eight (28) West, Stearns County, Minnesota, containing 40 acres, more or less."

Subsection 3. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of Stearns County and the Minnesota Municipal Commission.

Subsection 4. Effective Date of Annexation. This ordinance takes effect upon the passage and publication and the filing of the certified copies as directed in Subsection 3 above.
