ORDINANCE NO. 449

AN ORDINANCE DECLARING CERTAIN PLATTED LAND TO BE ANNEXED TO THE CITY OF NORTH MANKATO, MINNESOTA.

The Common Council of the City of North Mankato, Minnesota, does ordain as follows:

1. That the following described tracts of land are contiguous to each other, are bordered on three sides by the municipal boundaries of the City of North Mankato and are platted and urban in character:

Lots 24, 25, 26, 27, 28, 31, 32, 34, 35, 36, 37, 38, 39, 40 and 41, Pleasantview Subdivision, according to the map or plat thereof on file and of record in the office of the Register of Deeds in and for Nicollet County, Minnesota.

2. Said above described lands are hereby declared annexed to and made a part of the City of North Mankato, Nicollet County, Minnesota, according to Minnesota Statute 414.03, sub. 2.

3. This Ordinance shall take effect from and after its date of passage and publication.

ORDINANCE NO. 452

AN ORDINANCE AMENDING ORDINANCE NO. 449 DECLARING  
CERTAIN PLATTED LAND TO BE ANNEXED TO THE CITY OF  
NORTH MANKATO, MINNESOTA.

The Common Council of the City of North Mankato does ordain as follows:

Section 1. That Section 1 of Ordinance No. 449 declaring certain platted land to be annexed to the City of North Mankato, Minnesota, be deleted and the following substituted in lieu thereof:

"1. That the following described tracts of land are contiguous to each other, are bordered on three sides by the municipal boundaries of the City of North Mankato, and are platted and urban in character:

"Lots 24, 25, 26, 27, 28, 31, 32, 34, 35, 36, 37, 38, 39, 40 and 41, Pleasantview Subdivision, according to the map or plat thereof on file and of record in the office of the Register of Deeds in and for Nicollet County, Minnesota, together with any and all streets, highways and other public right of ways within and adjacent to said described land."

Section 2. This Ordinance shall take effect from and after its date of passage and publication.
