ORDINANCE NO. 1135

EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ADJUTING THE CITY OF AUSTIN LIMITS.

WHEREAS, a certain petition dated May 17, 1968, requesting annexation of the territory described herein was duly presented to the Common Council on the 20th day of May, 1968, and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is approximately .4 acres of platted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the Petition was signed by all of the owners, and

WHEREAS, no objections to the annexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed, and

WHEREAS, the land described hereinafter abuts the City limits on the North boundaries thereof,

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The City Council hereby determines that the annexation will be to the best interests of the City and of the territory effected. That the territory described herein abuts the City limits and is urban or suburban in character and that none of said territory is now included within the limits of any city, village or borough.

SECTION 2: The Corporate limits of the City of Austin are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof:

Lot One (1) and Lot Two (2) of Meald Sub-Division of a Outlot Nine (9) in the Northeast Quarter of the Northwest Quarter of Section Four (4), Township 102 North, Range 10 West, in Nowar County, Minnesota. Also all the right title and interest in and to the middle of the public highway and street known as 19th Street NW that abuts on the above property on the West; also all the right title and interest in and to the middle of the public highway and street known as Sixth Avenue N.W. that abuts on the above property on the South.

SECTION 3: The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, Secretary of State and the County Auditor.

SECTION 4: This Ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
