SECTION 2: The Corporate limits of the City of Austin are hareby extended to include the platted land described as follows and the same is hereby annexed to and included within the City as offectually as if it had originally been a part thereof:

Also all the right title and interest in end to the middle of the public highway and street known as 19th Street NU that abuts on the above property on the West; also all the right title and interest in and to the middle of the public highway and street known as Sixth Avenue N.W. that abuts on the above property on the South.
