AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF CAMBRIDGE, ISANTI COUNTY, MINNESOTA, TO INCLUDE CERTAIN PROPERTY OWNED BY SAID VILLAGE.

THE VILLAGE COUNCIL OF CAMBRIDGE, MINNESOTA, ORDAINS:

Section 1. Territory Annexed. The corporate limits of the Village of Cambridge, Isanti County, Minnesota, are hereby extended to include the property hereinafter described and now owned by said Village of Cambridge, to-wit:

That part of the North Half of the Northeast Quarter (N½ of NE½) of Section Five (5), Township Thirty-five (35), North, Range Twenty-three (23) West, described as follows, to-wit:

Commencing at a point on a line drawn 50 feet north of and parallel to the centerline of State Trunk Highway No. 293, as now constructed, 334.52 feet West of the Intersection of said line with the westerly right-of-way line of State Trunk Highway No. 65, as now located; thence North to a point on the North line of said Section Five (5), 539.5 feet West of the centerline of State Trunk Highway No. 65, as now located; thence East on the North line of said Section Five (5), to the northwest corner of Lot Two (2), First Re-arrangement of Whispering Pines Addition, according to the plat thereof, on file and of record in the office of the Register of Deeds in and for said County and State; thence South along the West plat line of said First Re-Arrangement of Whispering Pines Addition, 451.75 feet, and to a point 50 feet north of the centerline of said State Trunk Highway No. 293; thence West to the point of beginning and there to terminate.

Also, a strip of land 33 feet wide and approximately 1/4 mile long, in the S-1/2 of the SE-1/4 of Section 32, T36N, R23W, which lies West of Lot 10 and Lot 11 Auditors Subdivision No. 9, Village of Cambridge, and which is described by metes and bounds as follows: Commencing at the SW corner of Lot 10, being the SW corner of the Village limits; thence North along the west line of said Lots 10 and 11, being the West line of the Village limits, a distance of approximately 1320 feet to the NW corner of said Lot 11; thence Westerly a distance of approximately 33 feet; thence South along a line that is 33 feet West and parallel to the West line of said Lots 10 and 11 to the South line of said Section 32; thence Easterly to the SW corner of said Lot 10 to point of commencement and there to terminate.

Section 2. Filing. The Village Clerk is hereby directed to file certified copies of this Ordinance in the office of Secretary

Section 3. Effective Date of Annexation. Annexation shall be complete from and after the date when certified copies of this Ordinance have been filed as directed in Section 2 hereof.
