AN ORDINANCE OF ANNEXATION

THE CITY COUNCIL OF THE CITY OF TRACY, MINNESOTA, DO ORDAIN, as follows:

SECTION I. That George Elakeslee Nehls and Esther K. Nehls are the owners of the tracts or parcels of land lying and being in the County of Lyon and State of Minnesota, described as follows, to-wit:

A part of the Basterly 6.88 acres of the Southwest Quarter of the Southwest Quarter (SW/SW4), of Section Thirteen (13), Township One Mundred Nine (109) North, Range Forty (40) West of the Fifth Principal Meridian, described by metes and bounds as follows, towit: Beginning in the Southwest corner of said Section Thirteen (88) and continuing Bast One Thousand Ninety Three (1093) feet to the point of beginning; thence continuing Bast along said section line One Hundred Twenty (120) feet; thence North at right angles One Hundred Ninety (190) feet, thence West at right angles One Hundred Twenty (120) feet, thence South at right angles One Hundred Ninety (190) feet to the point of beginning.

SECTION 2. That all of the above described premises are surrounded by property now within the municipal limits of the City of Tracy, Minnesota.

SECTION 3. That pursuant to and in accordance with the provisions of Minnesota Statutes Section 414.03, the City Council of the City of Tracy do hereby annex to the City of Tracy, the premises above described.
