

ORDINANCE NO. 99

AN ORDINANCE OF ANNEXATION

THE CITY COUNCIL OF THE CITY OF TRACY, MINNESOTA, DO ORDAIN,  
as follows:

SECTION I. That the City of Tracy, Minnesota, is the owner  
of the tracts or parcels of land lying and being in the County of Lyon  
and State of Minnesota, described as follows, to-wit:

Commencing at the Southwest corner of Block Two (2) of O'Brien's  
Addition to the City of Tracy, Minnesota; thence South a dis-  
tance of 474.2 feet to a point on the extension Southerly of  
the East line of Fourth Street East; thence Westerly at right  
angles a distance of 60 feet; thence Northerly and along the  
extension line Southerly of the West line of Fourth Street  
East a distance of 474.2 feet to the Southeast corner of Block  
One (1) of O'Brien's Addition to the City of Tracy, Minnesota;  
thence Easterly to the point of beginning.

SECTION II. That the foregoing described property is abutting  
to other property now located within the municipal limits of the  
City of Tracy, Minnesota, the Northerly boundary of said property abutting  
property within the municipal limits of the City of Tracy, Minnesota.

SECTION III. That pursuant to and in accordance with the pro-  
visions of Minnesota Statutes Section 414.03, the City Council of the City  
of Tracy do hereby annex to the City of Tracy, the premises above described.
