## ORD. NO. 68-107

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MANKATO TO IN-CLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the city of Mankato, Minnesota and is deemed to be urban in character;

The City of Mankato does ordain:

That the corporate limits of the City of Mankato, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Lots Two through Seven, inclusive, and Lots Twelve through Seventeen, inclusive, in Block Two, Scheurer's Sunray Addition Number Three.

The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Blue Earth County and the Minnesota Municipal Commission.

This Ordinance shall take effect ten (10) days after the date of its passage and publication and the filing of certified copies as set forth herein.
