PUBLICATION NO. 1099 ORDINANCE NO. 306

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HUTCHINSON AND ANNEXING THERETO CERTAIN UNPLATTED LAND FORMERLY LOCATED IN THE TOWNSHIP OF ACOMA.

THE CITY OF HUTCHINSON DOES ORDAIN:

Section 1. A petition has been filed with the governing body of the (ity of Hutchinson, Minnesota, by Leonard Krulikosky and Harriet J. Krulikosky, being the owners of the following described real estate, to have said property annexed and included within the corporate limits of the City of Hutchinson, County of McLeod, State of Minnesota, to-wit:

Part of the SW½ of Section 36, T117, R30 McLeod County, Minnesota described as follows: Beginning at a point 402.3 feet $N89^{\circ}-04'E$ of a point 200 feet $N75^{\circ}-37'E$ of a point on the West line of said Sec. 36, a distance of 661.4 feet north of the Southwest corner of said Sec. 36; thence $S89^{\circ}-04'W$ a distance of 402.3 feet; thence South, a distance of 220 feet; thence $S60^{\circ}-20'E$, a distance of 222.94 feet; thence South to the Northerly right-of-way line of State Highway No. 7; thence Northeasterly along said right-of-way line, a distance of 374.3 feet more or less to a point bearing $S23^{\circ}-23'E$ from the point of beginning; thence $N23^{\circ}-23'W$ a distance of 360 feet to the point of beginning, containing 3.9 acres more or less.

Section 2. The quantity of land embraced within the foregoing description, and bound as described, is less than 200 acres. (3.9 acres)

Section 3. The City Council hereby determines: (1) that the annexation will be to the best interests of the City of Hutchinson, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

Section 4. Therefore, the City of Hutchinson, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of Hutchinson, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be if force and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
