Ordinance No. 1133

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ADJUTING THEREON TO THE WEST.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough, and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City, and is deemed to be urban in character,

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The corporate limits of the City of Austin are hereby extended to include the platted and unplatted territory described as follows, which territory now is, and has heretofore been completely surrounded by territory already included within the city limits:

Lot 5, Crestwood Hills First Addition and all that part of the northwest quarter of the southwest quarter of Section 4, Township 102 North, Range 13 West, Hower County, Minnesota, lying west of Lot 4, South Streverling Addition to the City of Austin, and north of the south line of Lot 2, Block 3, South Streverling Addition extended west to the center of Turtle Creek, and east of the center line of Turtle Creek, and south of the south line of Lot 5, Block 1, South Streverling Addition extended west to the center line of Turtle Creek.

SECTION 2: The City Recorder is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor in the County in which the property is located, and the Minnesota Municipal Commission.

SECTION 3: This Ordinance takes effect upon passage and publication and filing certified copies as directed in Section 2.
