ORDINANCE NO. 111
AN ORDINANCE ANNEXING CERTAIN REAL ESTATE TO THE
VILLAGE OF TYLER, MINNESOTA

The Village Council of the Village of Tyler does ordain as follows:

1. That all of the owners of the real estate hereinafter described have petitioned the Village Council to annex to and incorporate said land into the Village of Tyler.
2. That said land is platted and abuts on said Village of Tyler.
3. That it is for the best interest of all concerned that said land be so annexed to the Village of Tyler, Minnesota.
4. That the real estate lying and being in the County of Lincoln and State of Minnesota, described as follows, to-wit:

The South 111 feet of the East 150 feet of Lot One (1) of Block Three (3), and the East 542 feet of Lot One (1) of Block Four (4), all in Auditor's First Subdivision of Section Ten (10), Township One Hundred Nine (109) North, of Range Forty-four (44) west of the Fifth Principal Meridian, according to the Plat of said Subdivision on file and of record in the office of the Register of Deeds in and for Lincoln County, Minnesota, including abutting streets and right-of-way,

be, and the same hereby is annexed to and incorporated in the Village of Tyler, Minnesota.

5. This ordinance shall become effective upon its passage and publication and upon filing of a copy of said ordinance with the Minnesota Municipal Commission, the Secretary of State and the County Auditor of the County of Lincoln, Minnesota.
