
The property involved is described as per attached.

A Tract of land situated in the Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) of Section Thirty-four (34), Township Sixty-one (61) North, Range Twenty-six (26), West of the Fourth Principal Meridian, more particularly described as follows: The West Boundary of the said Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) is assumed a North and South bearing, and the point of beginning being a point Seven Hundred Thirty-six and 47/100 Feet (736.47') South and Thirty-two and 99/100 Feet (32.99') East of the Northwest Corner of said Northwest Quarter of Northwest Quarter (NW 1/4 of NW 1/4). Thence North Eighty-eight Degrees Thirty-nine Minutes (88° 39') East, Three Hundred Seventy-six and 10/100 Feet (376.10'). Thence South Fifty-five Degrees Forty-nine Minutes (55° 49') East One Hundred Twenty and 00/100 Feet (120.00') to Trunk Highway #38 right of way. Thence South Thirty-four Degrees Eleven Minutes (34° 11') West, Six Hundred Twenty-seven and 89/100 Feet (627.89') along said right of way to the South Boundary of said Northwest Quarter of Northwest Quarter (NW 1/4 of NW 1/4). Thence South Eighty-eight Degrees Thirty-nine Minutes (88° 39') West along said South Boundary One Hundred Twenty-two and 51/100 Feet (122.51'). Thence North Five Hundred Eighty and 85/100 Feet (580.85') to the point of beginning, tract contains Four and 17/100 (4.17) acres more or less, according to the Government Survey thereof, on file and of record in the office of the Register of Deeds of said County and State.
