



ORDINANCE NO. 185

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE VILLAGE OF FOREST LAKE TO INCLUDE CERTAIN
UNINCORPORATED PROPERTY OWNED BY AND ABUTTING
UPON THE LIMITS OF THE VILLAGE

WHEREAS, the territory described below is not presently within
the corporate limits of any incorporated city, village or borough, and

WHEREAS, this territory abuts upon the corporate limits of the
Village at the West boundary thereof and is deemed to be urban in
character, and

WHEREAS, this territory is owned in fee by the Village of Forest
Lake,

THE VILLAGE COUNCIL OF THE VILLAGE OF FOREST LAKE,
WASHINGTON COUNTY, MINNESOTA, ORDAINS:

Section 1. The corporate limits of the Village of Forest Lake are
hereby extended to include the unplatted property described as follows,
now owned by the Village:

That part of the East Half of the Southeast Quarter
(E 1/2 of SE 1/4) Section Six (6), Township Thirty-two
(32) North, Range Twenty-one (21) West, lying Southerly
and Easterly of that part of said East Half of the Southeast
Quarter (E 1/2 of SE 1/4) which has been acquired by the
State of Minnesota for construction of Interstate Highway
No. 35 and TH #8, Washington County, Minnesota.

Section 2. The Village Clerk is directed to file certified copies
of this Ordinance with the Secretary of State, the County Auditor of

Washington County, and the Minnesota Municipal Commission.

Section 3. This Ordinance takes effect upon its passage and publication and the filing of Certified copies as directed in Section 2 hereof.
