ORDINANCE NO. 1138

AN ORDINANCE EXTENDING THE CORFORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING 200 ACRES ABUTTING THE CITY LIMITS.

WHEREAS, a Patition was filed requesting the unnexation of the territory hereinafter described, which Patition was duly presented to the Common Council on the let day of July, 1968, and

WHEREAS, the quantity of lands embraced within the erea described in the Petition and bounded as described is _/6.1 acres of unplatted land, no part of which is included within the limits of an incorporated city, village or borough, and

WHEREAS, the Petition was signed by all the owners, and

WIEREAS, no objections to the ennexation have been received from the Town Board, the County Board or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the Petition abuts upon the City of Austin at the North boundary thereof;

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTIONAL) The City Council hereby determines, 1) that the annexation will be to the best interests of the City and of the territory affected. 2) that the territory described herein abuts the city limits, and is bout to become urban or suburban in character, and 3) that none of said territory is now included within the limits of any city, village or borough.

SECTION 2) The corporate limits of the City of Austin are hereby extended to include the unplatted land described as follows, and the same is hereby ennexed to and included within the City of Austin as effectually as if it had originally been a part thereof:

Beginning at the northwest corner of Lot 7, Blk. 5, Carlotto Third Addition to the City of Austin, as the seem is platted and recorded in the Office of the Register of Deeds of Mower County, Minnesots; thence southerly along the west line of said Carlotto 3rd Addition 673.86 feet, more or less, to the south line of 13th Avenue NV; thence westerly 1,111 feet, more or less, along an extension of said 19th Avenue NW to the west line of Section 34, Twp. 103 North, Range 18 West; thence northerly 653,86 feet, more or less, along the west line of said section 34 to the south right-of-way line on I.H. No. 90; thence southwesterly 1,257 feet, more or less, along the south right-of-way line of I.M. No. 90 to a point where said south right-of-way line intersects the centerline of the north bound land on T. H. 218; thence north 1,205 feet, more or less, along said north bound centerline; thence easterly 161 feet to the north rightof-way line of I. H. No. 30; thence southeasterly elong said north right-of-way line of I. H. No. 90 a distance of 650 feet; thence easterly along said north right-ofway line of I. H. No. 90 a distance of 2,900 feet, more or less, to the north and south centerline or said section 34: thence southerly along said section 34 centerline a

distance of 360 feet, more or less, this being the intersection of the north line of said Carlotto Brd Addition extended to the east to the centerline of said section 84; thence westerly along said north line of Carlotto 3rd Addition 1,545 feet, more or less, to the northwest corner of Lot 7, Blk. 5, Carlotto 3rd Addition, said point being the point of beginning.

SECTION 3) The City Recorder is hereby directed to file certified copies of this Ordinance with the Minnesote Municipal Commission, the Secretary of State and the County Auditor.

SECTION 4) The Ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
