ORDINANCE NO. 425

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WORTHINGTON, MINNESOTA, TO INCLUDE CERTAIN UNPLATTED LANDS.

The City Council of the City of Worthington Do Ordain:

Section 1. A petition has been filed with the City Council of the City of Worthington, Minnesota, signed by all of the owners in number of the following described real estate, to have such land included within the City of Worthington, Minnesota:

A tract of land in the South Half (S<sup>1</sup>/<sub>2</sub>) of Section 15, Township 102, Range 40, described as follows: Commencing at the northwest corner of Lot 1, Block 4, Homewood Hills Third Addition to the City of Worthington, as the point of beginning, thence West to the southwest corner of Lot 1, Block 2, Homewood Hills Third Addition to the City of Worthington; thence north on the west line of Homewood Hills Third Addition a distance of 876 feet to the northwest corner of Lot 4, Block 3, of said Homewood Hills Third Addition; thence west at 90° for 320 feet; thence south at 90° for 876 feet; thence east at 90° for 225 feet; thence south at 90° for 431 feet, more or less, to the south section line of said Section 15; thence east on said south section line 415 feet; thence north at 90° for 224 feet; thence east at 90° for 94 feet; thence north at 90° for 82 feet to the south line of Lot 7, Block 2, Homewood Hills First Addition; thence west along the south line of said Lot 7, the south line of Lot 8, Block 2, and the South line of Lot 1, Block 4, Homewood Hills Third Addition, for 194 feet to the southwest corner of said Lot 1, Block 4; thence north along the west line of said Lot 1, Block 4, for 125 feet to the point of beginning; all in Nobles County, Minnesota.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is 10.43 acres.

Section 3. Notice was duly given the Board of Commissioners for Nobles County and the Board of Commissioners for Worthington Township on April 29, 1968, that said petition was being considered by the City Council of the City of Worthington and a hearing was duly held by the City Council of the City of Worthington, on the proposed annexation after publication of notice of hearing as required by City Charter.

Section 4. The City Council hereby determines (1) that the annexation will be to the best interests of the City of Worthington, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 5. The corporate limits of the City are hereby extended to include the property described in Section 1, and the same is hereby annexed to, and included in the City as effectually as if it had originally been a part thereof.
