Ordinance No. 26

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF ROCKVILLE TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated July 6, 1968, requesting annexation of the territory hereinafter described was duly presented to the council on the <u>6th</u> day of <u>July</u>, 1968; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is approximately 11.84 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by all the owners of said land; and

WHEREAS, no objections to the annexation have been received from the town board of Rockville Township, the Stearns County Board of Commissioners, or the Minnesota Municipal Commission, said bodies having due notice as provided by statute; and

WHEREAS, the land described in the petition abuts the village limits at the west boundary thereof;

The Council of the Village of Rockville, Minnesota, ordains:

Section 1. The village council hereby determines (1) that the annexation will be to the best interests of the village and of the territory affected; (2) that the territory described herein abuts upon the village limits and is about to become urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the village are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the village as effectually as if it had originally been a part thereof:

All that part of the West One-half of the Northeast Quarter of the Northeast Quarter (W 1/2 of NE 1/4 NE 1/4) of Section Seventeen (17), Township One Hundred Twenty Three (123) North, of Range Twenty-nine (29) West, Stearns County, Minnesota, lying southerly of State Trunk Highway #23; and The East One Hundred Seventy-six (176.0) feet of the West Seven Hundred Eighty-nine and Fifty-three Hundredths (789.53) feet of the North Two Hundred Forty-seven and Five Tenths (247.5) feet of the Southeast Quarter of the Northeast Quarter (SE 1/4 NE 1/4) of Section Seventeen (17), Township One Hundred Twenty-three (123) North, of Range Twenty-nine (29); West; and

The North Two Hundred Forty-seven and Five Tenths (247.5) feet of the Southeast Quarter of the Northeast Quarter (SE 1/4 NE 1/4) of Section Seventeen (17), Township One Hundred Twenty-three (123) North, of Range Twenty-nine (29) West, except the West Seven Hundred Eighty-nine and Fifty-three Hundredths (789.53) feet thereof; subject to an easement over the South 33.0 feet thereof to be used with others for purpose of ingress and egress.

Section 3. Filing. The village clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

<u>Section 4. Effective Date.</u> This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3.
