

ORDINANCE NO. 58

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF WELCOME, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LANDS NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE VILLAGE LIMITS.

WHEREAS, a certain petition dated July 2, 1968, requesting annexation of the territory hereinafter described was duly presented to the council on the 2nd day of July, 1968; and,

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 14.2 acres, more or less, of unplatted land, no part of which is included within the limits of any incorporated city, village, or borough; and,

WHEREAS, the petition was signed by all the owners, constituting all of the total number of two owners; and,

WHEREAS, no objections to the annexation have been received from the town board of Fox Lake Township, Martin County, Minnesota, the county board of Martin County, Minnesota, Minnesota Municipal Commission, nor by anyone whatsoever; and,

WHEREAS, a hearing was duly held by the governing body of the village of Welcome, Minnesota, on the proposed annexation after more than 30 days have elapsed since the service of a copy of this Petition for Annexation has been made upon the Township of Fox Lake, Martin County, Minnesota, the County of Martin, Minnesota, and upon the Minnesota Municipal Commission of the State of Minnesota, proof of which service is on file with the Clerk of the Village of Welcome, Minnesota; and,

WHEREAS, the land described in the petition abuts upon the village limits at the North and South boundaries thereof;

The council of the village of Welcome, Minnesota, ordains:

Section 1. The village council hereby determines (1) that the annexation will be to the best interests of the village of Welcome, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the village limits and is urban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the village of Welcome, Minnesota, are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the village of Welcome, Minnesota, as effectually as if it had originally been a part thereof:

A tract of land lying in the SE $\frac{1}{4}$ of the SE $\frac{1}{2}$ of Section 36, T 103 N, R 32 W, of the Fifth Principal Meridian in Fox Lake Township, Martin County, Minnesota, more particularly described as follows:

Commencing at the Southeast corner of Section 36, T 103 N, R 32 W, thence North 330 feet on the East line of said Section 36 to the point of beginning, thence West 734.00 feet parallel to the South line of said Section 36, thence North 840.98 feet parallel to the East line of said Section 36, thence East at right angles 733.99 feet to the East line of said Section 36, thence South 838.60 feet on the East line of said Section 36, to the point of beginning, containing 14.2 acres, more or less, and subject to easements now of record in said County and State.

Section 3. Filing. The village clerk of the village of Welcome, Minnesota, is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State of the State of Minnesota, and the County Auditor for Martin County, Minnesota.

Section Four. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3 hereof.
