

ORDINANCE NO. 391

AN ORDINANCE DETERMINING THE ANNEXATION OF CERTAIN LAND TO BE IN THE BEST INTERESTS OF THE CITY OF STILLWATER AND OF THE TERRITORY AFFECTED AND DECLARING SAME TO BE ANNEXED TO THE CITY.

THE COUNCIL OF THE CITY OF STILLWATER DO ORDAIN AS FOLLOWS:

SECTION 1. The following territory, consisting of unplatted land not exceeding two hundred (200) acres in all, abutting upon the City of Stillwater, Washington County, Minnesota, being so conditioned as properly to be subject to municipal government and not included in any other municipality, upon petition of all the owners in number, and in the best interests of the City of Stillwater and of said territory, is hereby declared to be annexed to the said City, to-wit:

All that part of the following described land, to-wit:

That part of the Northeast Quarter (NE $\frac{1}{4}$) of Section 32, Township 30 North, Range 20 West, in the Township of Stillwater, Washington County, Minnesota, described as follows, to-wit: Commencing at the Northeast corner of Section 32, Township 30 North, Range 20 West, Washington County, Minnesota; thence Westerly along the North line of said Section 32, bearing North 89°51' West, for 1694.7 feet to the easterly line of the public road; thence South 6°00' East along the easterly line of said public road for 664.9 feet to the southerly line of the present City Limits of the City of Stillwater, being the point of beginning of this description; thence South to the Northwest corner of the real estate conveyed to Nicholas R. Nelson and Kathryn Mayer Nelson; thence continuing South 6°00' East along said easterly line of the public road for 51.4 feet; thence South 0°13' West along said easterly line of the public road for 48.3 feet to the Southwest corner of the real estate conveyed to the said Nelson; thence West for a distance of sixty (60) feet; thence Northerly and 60 feet West of the Easterly line of the roadway hereinbefore described to a point where said line intersects the Southerly boundary line of the City of Stillwater; thence Southeasterly along said boundary line of the City of Stillwater to the point of beginning of this description;

and also all that part of the following described land which lies outside of the present boundaries of the City of Stillwater, to-wit:

All that part of the Northeast Quarter (NE $\frac{1}{4}$) of Section Thirty-two (32), Township Thirty (30) North, Range Twenty (20) West, in the City of Stillwater and Township of Stillwater, Washington County, Minnesota, described as follows: Commencing at the northeast corner of Section 32, Township 30 North, Range 20 West, Washington County, Minnesota; thence westerly along the North line of said Section 32, bearing North 89°51' West, for One Thousand Six Hundred Ninety-four and seven-tenths (1694.7) feet to the easterly line of the public road; thence South 6°00' East along the easterly line

of said public road for Six Hundred Eighty-nine and nine-tenths (689.9) feet to the point of beginning of this description; thence continuing South 6°00' East along said easterly line of the public road for Fifty-one and four-tenths (51.4) feet; thence South 0°13' West along said easterly line of the public road for Forty-eight and three-tenths (48.3) feet; thence South 89°51' East parallel with said North line Section Thirty-two (32), for One Hundred Eighty and three-tenths (180.3) feet; thence North 6°00' West for One Hundred (100.0) feet; thence North 89°51' West, parallel with said North line Section 32, for One Hundred Seventy-five (175.0) feet, to the point of beginning. Containing 0.40 acres, more or less. According to the United States Government Survey thereof.

SECTION 2. The above described territory shall be incorporated in and become a part of the First Ward, Second Precinct, of the City for election purposes until otherwise designated by the City Council as provided by law.

SECTION 3. This ordinance shall be in full force and effect from and after its passage and publication according to law and upon filing a copy of the ordinance with the Minnesota Municipal Commission, the Auditor of Washington County, and the Secretary of State. Thereupon such territory shall become a part of the City of Stillwater as effectually as if it had originally been a part thereof.

ORDINANCE NO. 391

AN ORDINANCE DETERMINING THE ANNEXATION OF CERTAIN LAND TO BE IN THE BEST INTERESTS OF THE CITY OF STILLWATER AND OF THE TERRITORY AFFECTED AND DECLARING SAME TO BE ANNEXED TO THE CITY.

THE COUNCIL OF THE CITY OF STILLWATER DO ORDAIN AS FOLLOWS:

SECTION 1. Nelson and Kathryn Mayer Nelson; thence continuing South 6°00' East along said easterly line of the public road for 51.4 feet; thence South 0°13' West along said easterly line of the public road for 48.3 feet to the Southwest corner of the real estate conveyed to the said Nelson; thence West for a distance of sixty (60) feet; thence Northerly and 60 feet West of the Easterly line of the roadway hereinbefore described to a point where said line intersects the Southerly boundary line of the City of Stillwater; thence Southeasterly along said boundary line of the City of Stillwater to the point of beginning of this description;

and also all that part of the following described land which lies outside of the present boundaries of the City of Stillwater, to-wit:

All that part of the Northeast Quarter (NE $\frac{1}{4}$) of Section Thirty-two (32), Township Thirty (30) North, Range Twenty (20) West, in the City of Stillwater and Township of Stillwater, Washington County, Minnesota, described as follows: Commencing at the northeast corner of Section 32, Township 30 North, Range 20 West, Washington County, Minnesota; thence westerly along the North line of said Section 32, bearing North 89°51' West, for One Thousand Six Hundred Ninety-four and seven-tenths (1694.7) feet to the easterly line of the public road; thence South 6°00' East along the easterly line

of said public road for Six Hundred Eighty-nine and nine-tenths (689.9) feet to the point of beginning of this description; thence continuing South 6°00' East along said easterly line of the public road for Fifty-one and four-tenths (51.4) feet; thence South 0°13' West along said easterly line of the public road for Forty-eight and three-tenths (48.3) feet; thence South 89°51' East parallel with said North line Section Thirty-two (32), for One Hundred Eighty and three-tenths (180.3) feet; thence North 6°00' West for One Hundred (100.0) feet; thence North 89°51' West, parallel with said North line Section 32, for One Hundred Seventy-five (175.0) feet, to the point of beginning. Containing 0.40 acres, more or less. According to the United States Government Survey thereof.

SECTION 2. The above described territory shall be incorporated in and become a part of the First Ward, Second Precinct, of the City for election purposes until otherwise designated by the City Council as provided by law.

SECTION 3. This ordinance shall be in full force and effect from and after its passage and publication according to law and upon filing a copy of the ordinance with the Minnesota Municipal Commission, the Auditor of Washington County, and the Secretary of State. Thereupon such territory shall become a part of the City of Stillwater as effectually as if it had originally been a part thereof.
