AN ORDINANCE TO AMEND THE CHARTER OF THE CITY OF STAPLES, MINNESOTA, AND TO AUTHORIZE THE CITY COUNCIL TO TAKE SUCH ACTION AS MAY BE NECESSARY TO CARRY OUT THE SAME

The City Council of the City of Staples do ordain as follows:

SECTION 1. A petition has been filed with the governing body of the City of Staples, Minnesota, by the owners of the following described tracts of so 1 estate to have such tracts included within the City of Staples, Minnesota:

All of the east half (50%) of Block One (1) of Sherkey and Grant's addition to Staples, including all streets and alleys situated therein,

and

The westerly 100 feet of the hereinafter described parcel of land: commencing at a point on the quarter line 35 feet west of the southeast corner of Lot 10, Block 1 of Sherkey and Grant's addition to Staples, Minnesota, thence north along the quarter line a distance of 594.2 feet to the point of beginning; thence due west a distance of 145.5 feet to the eastern boundary line of Sixth Street, thence running south along the east boundary line of Sixth Street to the northwest corner of Lot 6, Block 1 of Sherkey and Grant's addition to Staples, Minnesota, thence east along the north line of Section 1, Township 135, Range 35, being a part of the so of the so of Section 1, Township 135, North, Range 35 east of the 3d. P. M., including all streets and alleys therein or abutting thereon.

SECTION 2. The quantity of land embraced within the foregoing described parcels and bounded as described is less than two hundred acres.

SECTION 3. Notice of the filing of the petition has been filed with the Staples Loan Board, County Auditor of St. Louis County and with the Minnesota Municipal Commission at least 30 days prior to the first reading of this ordinance.

SECTION 4. All fees required to be paid by the petitioners have been duly paid.

SECTION 5. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota, and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City Government.

SECTION 6. Therefore, the City of Staples, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.

SECTION 7. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
