AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF STAPLES AND INCORPORATING ADDITIONAL TERRITORY THEREIN

The City Council of the City of Staples do ordain as follows:

SECTION 1. A petition has been filed with the governing body of the City of Staples, Minnesota by the owners of the following described tracts of real estate to have such tracts included within the City of Staples, Minnesota:

Lots Five (5), Six (6), Seven (7), Eight (8) and Nine (9) of Block Six (6), O'Connor Addition to Staples, according to the plat thereof on file and of record in the office of the Register of Deeds in and for said County and State, including all streets and alleys therein or abutting thereon.

The following described tract of land is entirely surrounded by property presently within the city and said tract is non-agricultural land and is suitable for urban purposes:

The East 38 feet of Lot 1 of Block 2; the South Half of Lot 4 of Block 2 and Lots 2 and 3 of Block 2 of O'Connor Addition to Staples, including all streets and alleys therein or abutting thereon.

Notice of annexation has been served and filed at least thirty (30) days prior to the first reading of the ordinance with respect to the tract in Block 6 and at least sixty (60) days prior to the first reading of this ordinance with respect to the tract in Block 2.

- SECTION 2. The quantity of land embraced within the foregoing described parcels and bounded as described is less than three acres.
- SECTION 3. Notice of the filing of the petition has been filed with the Staples Town Board, County Auditor of Todd County and with the Minnesota Municipal Commission at least 30 days prior to the first reading of this ordinance.
- SECTION 4. All fees required to be paid by the petitioners have been duly paid.
- SECTION 5. The City Council hereby determines that the annexation will be to the best interests of the City of Staples, Minnesota, and of the territory affected; that the territory described herein abuts upon the City and is so conditioned as properly to be subject to City Government.
- SECTION 6. Therefore, the City of Staples, Minnesota hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Staples, Minnesota, as effectually as if it had originally been a part thereof.
- SECTION 7. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
