BALLOT ON AMENDMENTS TO CITY CHARTER OF THE CITY OF GLENWOOD

GENERAL ELECTION NOV. 5, 1968

1. Shall Section 6 of Chapter 2 of the Charter of the City of Glenwood be amended to read as follows:

"The elective officers of the City shall be a Mayor, four Commissioners, and two Justice of the Peace, all of whom shall be elected from the City at large. The Mayor shall be elected in odd numbered years for a term of four years. Two Commissioners shall be elected biennially in odd numbered years for a term of four years, and two Justices of the Peace shall be elected biennially in odd numbered years for a term of two years.

odd numbered years, and the busices of all a construction of the first The terms of all officers shall begin on the first Monday after the first Tuesday of January following the regular municipal election. All elective officers shall hold office until their successors are elected and have qualified."

(Explanation: The proposed change in the Charter is for the purpose of increasing the term of the Mayor of the City to four years from two years.)

2. Shall Section 11 of Chapter 2 of the Charter of the City of Glenwood be amended to read as follows:

"The Mayor shall receive an annual salary of Three hundred Dollars payable quarterly. The Commissioners shall each receive the sum of fifteen dolars for each meeting of the Commission at which such officer is in attendance throughout its entire session, payable quarterly, provided however, that no Commissioner shall receive in excess of One Hundred and Eighty Dollars in any one year. The other elective officers and all appointive officers and employees of the City shall receive such salaries or wages as may be fixed from time to time by resolution of the Commission."

(Explanation: The purpose is to increase the salary of the Mayor of the City to \$300.00 from \$100.00 and to increase the amount received by Commissioners for each meeting of the Commission at which a Commissioner is in attendance from \$5.00 to \$15.00 with the maximum amount payable to any one Commissioner in any one year to be \$180.00 instead of \$60.00.)



3. Shall Section 53 of Chapter 6 of the Charter of the City of Glenwood be amended to read as follows:

"In all cases of work to be done by contract, or of the purchase of personal property of any kind wherein the amount exceeds Two Thousand Dollars, unless the Commission by an emergency Ordinance otherwise provide, the Clerk shall advertise for bids in such manner as may be prescribed by the Commission. Contracts of this magnitude shall be let only to the lowest responsible bidder; provided that in the case of expenditure of surplus funds of the water and light department for extensions and expansion when such amount does not exceed five thousand dollars, no bids shall be required. Detailed regulations for the making of bids and the letting of contracts shall be provided by Ordinance, subject to the provisions and limitations of this Charter."

(Explanation: The purpose of this Amendment is to increase the amount which the Commission may purchase by contract for work or personal property without advertising and calling for bids from \$500.00 to \$2000.00 and to provide that the amount which may be expended from surplus funds of the water and light department for extensions and expansions shall be \$5000.00 instead of of \$2000.00 without requirements of bids.)

4. Shall Section 76 of Chapter 8 of the Charter of the City of Glenwood be amended to read as follows:

"Under this charter no cost of the improvement of street intersections or improvements lying therein or thereupon shall be assessed upon benefited property, but the City shall pay such costs from taxes through the permanent improvement fund. The City shall pay costs of improvements opposite its own property to the extent as an individual."

(Explanation: The purpose of this Amendment is to provide that the City shall pay costs of improvements opposite its property to the same extent as any individual. There is no change as to costs of improvements on street intersections.)



5. Shall Section 65 of Chapter 7, Paragraph "G" of the Charter of the City of Glenwood be amended to read as follows:

"A library fund for which there shall be levied annually a sum not less than One Thousand Dollars (\$1,000.00) and not to exceed five (5) mills on each dollar of taxable property in the City of Glenwood for the operation and maintenance of the public library."

(Explanation: The purpose of the Amendment is to provide that the amount assessed for JATE to Filmann and shall not exceed 5 mills rather than not to exceed 3 mills.) DEPARTMENT OF A
