

AN ORDINANCE EXTENDING THE CORPORATE  
LIMITS OF THE CITY OF WHITE BEAR LAKE TO  
INCLUDE CERTAIN UNPLATTED LAND NOT EX-  
CEEDING TWO HUNDRED ACRES

Section 1. A petition has been filed with the governing body of the City of White Bear Lake, Minnesota, by the sole owners of the following described real estate to have such land included within the City of White Bear Lake, Minnesota:

Subject to Easement, the North 112 ft. of the South 745 ft. of the West 313 ft. of Government Lot Two (2), Section Twenty-four (24), Township Thirty (30), Range Twenty-two (22).

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is less than two hundred (200) acres.

Section 3. The City Council hereby determines (1) that the annexation will be to the best interests of the City of White Bear Lake, Minnesota, and of the territory affected; (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. Therefore, the City of White Bear Lake, Minnesota, hereby ordains and declares that the property hereinbefore described by and the same is hereby annexed to, and included in, the City of White Bear Lake, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing Certified copy thereof with the Minnesota Municipal Commission, the County Auditor and Secretary of State, and from



AN ORDINANCE EXTENDING THE CORPORATE  
LIMITS OF THE CITY OF WHITE BEAR LAKE

EXCEEDING TWO HUNDRED ACRES

Section 1. A petition has been filed with the governing body of the City of White Bear Lake, Minnesota, by the sole owners of the following described real estate to have such land included within the City of White Bear Lake, Minnesota:

Subject to Easement, the North 112 ft. of the South 745 ft. of the West 213 ft. of Government Lot 2, Section 24, Township 30, Range 22.

Section 2. The quantity of land embraced within the foregoing description, and bounded as described, is less than two hundred (200) acres.

Section 3. The City Council hereby determines (1) That the annexation will be to the best interests of the City of White Bear Lake, Minnesota, and of the territory affected (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to City government.

Section 4. Therefore, the City of White Bear Lake, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in the City of White Bear Lake, Minnesota, as effectually as if it had originally been a part thereof.
