Ordinance No. 369

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MONTEVIDEO TO INCLUDE CERTAIN LANDS ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition requesting annexation of the territory hereinafter described was duly presented to the council on the 3rd day of July, 1968; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 2.94 acres of unplatted land, no part of which is included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition was signed by Arnold A. Styrbicky and Elizabeth L. Styrbicky, the owners of the premises therein described; and

WHEREAS, no objections to the annexation have been received from the town board, the County Board, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, the land described in the petition abuts upon the city limits at the Westerly boundary thereof;

The City of Montevideo does ordain:

-

Section 1. The city council hereby determines (1) that the annexation will be to the best interests of the city and of the territory affected; (2) that the territory described herein abuts upon the city limits and is urban or suburban in character; and (3) that none of said territory is now included within the limits of any city, village, or borough.

Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

That part of Lot Three (3) in the Plat of Lots in the West Half of the Northeast Quarter (W of NE) and East Half of the Northwest Quarter (It of NW.) east of the Chippews River, in Section Seven (7), Township One Hundred Seventeen (117), Range Forty (40), described as follows: Beginning at the southeast corner of said Lot Three (3), thence westerly along the south line of said Lot Three (3), a distance of 350 feet; thence northerly at right angles to said south line of Lot Three (3), 127 feet; thence westerly parallel to the said south line of Lot Three (3) a distance of 250 feet to the westerly line of said lot; thence northerly along the westerly line of said lot a distance of 25 feet; thence easterly parallel to the south line of said lot a distance of 284 feet; thence northerly parallel to the west line of said lot a distance of 61 feet; thence westerly parallel to the south line of said lot 14 feet; thence northerly parallel to the west line of said lot, 150 feet to the north line of said lot; thence east along the north line of said lot, 330 feet to the northeast corner of said lot; thence south slong the east line of said Lot Three (3) a distance of 363 feet to the point of beginning. containing 2.94 acres.

Section 3. That said premises are hereby annexed to and made a part of the City of Montevideo and are zoned as RM (Multiple Dwellings).

Section 4. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, the Secretary of State, and the County Auditor.

Section 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4.


