AN ORDINANCE CHANGING THE ANNUAL ELECTION IN THE VILLAGE OF COOLEY, ITASCA COUNTY, MINNESOTA, TO THE FIRST TUESDAY AFTER THE FIRST MONDAY IN THE MONTH OF NOVEMBER IN EACH YEAR HEREAFTER.

The Village Council of the Village of Cooley do ordain as follows:

Section 1. The Village Council of the Village of Cooley, Itasca County Minnesota, pursuant to the authority granted it under the provisions of Section 205.07, Subdivision One (1) of the Minnesota Statutes of 1967 elect to hold the general Village elections in the Village of Cooley on the First Tuesday after the First Monday in the Month of November in each year hereafter.

Section 2. This Ordinance shall take effect and be in force from and after its passage and publication.

tisements and sale of subscriptions and maintained by Alice R. and Rich-
ard Anderson subject to their direction and control during all such regular
business hours and at which said newspaper is printed. (6) Said news-
paper files a copy of each issue immediately with the State Historical
Society. (7) Said newspaper has complied with all the foregoing conditions
for at least two years preceding the day or dates of publication mentioned
below. (8) Said newspaper has filed with the Secretary of State of Min-
nesota prior to January 1, 1966 and each January 1 thereafter an affidavit
in the form prescribed by the Secretary of State and signed by the pub-
lisher of said newspaper and sworn to before a notary public stating that
the newspaper is a legal newspaper.
