ORDINANCE NO. 1137

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY WHICH IS 75 PERCENT OR MORE BORDERED ON THREE SIDES BY THE CITY OF AUSTIN

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough, and

WHEREAS, this territory is 75 percent or more bordered on three sides by the City of Austin, and is deemed to be urban in character.

WHEREAS, the Common Council of the City of Austin served notice of intention upon the Board of Supervisors of Austin Township, Mower County Minnesots, on May 21, 1968,

WHEREAS, no objections to the annexation have been received from the Town Board, where within the 60 day period as required by Chapter 414.03, Subdivision 2, Minnesota Statutes 1965:

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The corporate limits of the City of Austin are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the tity of Austin as if it had originally been a part thereof:

Beginning on the south line of the north one-helf of the northwest one-quarter of Section 4. Township 102 North, Range 18 West, Mower County, Minnesota at a point 1.016.59 feet west of the southeast corner thereof, this point being on the west right-of-way 0f 20th Street N.W., thence westerly 515.73 feet along the south line of the north one-half of said one-quarter section; thence northerly at a deflection angle to the right of 80° - 43′ - 30" a distance of 223.43′, thence easterly at a deflection angle to the right of 90° - 14′ - 15" a distance of 488.98 feet, this point also being on the west right-of-way of 20th Street N.W.; thence southerly at a deflection angle to the right of 89° - 51′ - 15" along the west right-of-way of 20th Street N.W. a distance of 3.07 feet; thence 187.59 feet southerly along the west line of 20th Street N.W. on a curve of 864.46 feet radius and through a central angle of 12° - 26" to the end point of said curve; thence 35.39 feet southeasterly on the same west line of 20th Street M.W. along the tangent to said curve at said end point to the point of beginning.

SECTION 2: The City Recorder is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of the County in which the property is located, and the Minnesota Municipal Commission.

SECTION 3: This Ordinance takes effect upon passage and publication and filing certified copies as directed in Section 2.
