ORDINANCE NO. 1139 (amending ordinance no. 1132)

AN AMENDED ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON TO THE WEST.

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, village or borough, and

WIEREAS, this territory is completely surrounded on all sides by land already included within the corporate limits of the City, and is deemed to be urban in character,

THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ONDAIN:

SECTION 1: The corporate limits of the City of Austin are hereby extended to include the platted territory described as follows, which territory now is, and has heretofore been completely surrounded by territory already included within the city limits:

> Lots 1 and 2, Crestwood Hills First Addition and the following portion previously deeded to Derrell Armstrong and Margaret E. Armstrong by a deed recorded in Book 230 of Deeds, page 1193: Deginning at the most northerly corner of Lot 3, Crestwood Hills First Addition. thence Southwesterly along the northerly line of said lot to the most westerly corner thereof; thence southeseterly 25 feet along the westerly line of said lot; thence northeasterly on a line parallel with the northerly line of said lot to the easterly line thereof; thence northeasterly along the easterly line of said lot to the point of beginning.

SECTION 2: The City Recorder is directed to file certified copies of this Ordinance with the Secretary of State. the County Auditor in the County in which the property is located, and the Minnesota Municipal Commission.

SECTION 3: This Ordinance takes effect upon passage and publication and filing certified copies as directed in Section 2.
