## ORDINANCE NO. 1143



and

EXTENDING THE CORPORATE LIMITS OF THE CITY OF AUSTIN TO INCLUDE CERTAIN UNINCORPORATED PLATTED LAND ABUTTING THE CITY OF AUSTIN LIMITS.

That, WHEREAS, A Certain petition dated July 31, 1968, requesting annexation of the territory described herein was duly presented to the Common Council on the 5th day of August, 1968, and

WHEREAS, the quantity of land embraced within the area described in the Petition and bounded as described is approximately .7 acres of land, no part of which is included within the limits of any incorporated city, village or borough, and

WHEREAS, the petition was signed by all of the owners,

WHEREAS, NO Objections to annexation have been received by the Town Board, the County Board or the governing body of any Municipality who's boundaries abuttupon the Boundaries of the land to be annexed, and

WHEREAS, the land described hereinafter abuts the City limits on the North boundaries thereof,

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF AUSTIN DO ORDAIN:

SECTION 1: The City Council hereby determines that the annexation will be to the best interest of the City and of the Territory affected. That the territory described herein abuts the City limits and is urban or suburban in character and that none of the said territory is now included within the limits of any city, village or borough.

SECTION 2: The corporate limits of the City of Austin are hereby extended to include the platted land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

> Lot three (3) in the Plat of Heald Subdivision, a subdivision of Outlot 9 in the NE% of the NW% of Section 4. TLO2N, RLSW. Also including 33 foot easement for roadway purposes along the south side of said tract, said roadway being 6th Avenue NW.

SECTION 3: The City Recorder is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Commission, Secretary of State and the County Auditor.

SECTION 4: This Ordinance takes effect upon its passage and publication and filing of the certified copies as directed in Section 3.
