ORDINANCE NO. 268

AN ORDINANCE ANNEXING CERTAIN LANDS TO THE CITY OF HUTCHINSON, McLEOD COUNTY, MINNESOTA

The City Council of the City of Hutchinson ordains:

SECTION I.

WHEREAS, Milton F. Altmeyer and Sylvia Altmeyer are the owners of the following described lands lying and being in the County of McLeod, State of Minnesota, and described as follows, to-wit:

The South Seven (7) feet of the West One Hundred Seventy (170) feet of Lot Fifteen (15) of the Auditor's Plat of the Northwest Quarter (NW 1/4) of Section One (1), Township One Hundred Sixteen North (116 N) Range Thirty West (30W).

WHEREAS, Junice A. Otterness is the owner of the following described lands lying and being in the County of McLeod, State of Minnesota, and described as follows, to-wit:

The North Ninety-Three (93) feet of the South One Hundred (100) feet of the West One Hundred Seventy (170) feet of Lot Fifteen (15) of the Auditor's plat of the Northwest Quarter (NW 1/4) of Section One (1), Township One Hundred Sixteen North (116N), Range Thirty West (30W).
