ORDINANCE NO. 386

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MARSHALL TO INCLUDE CERTAIN UNPLATTED LAND NOT EXCEEDING TWO HUNDRED ACRES.

The Common Council of the City of Marshall do ordain as follows:

Section 1. A petition has been filed with the Common Council of the City of Marshall, Minnesota, by the sole owner of the following described real estate in the County of Lyon, State of Minnesota, to have such land included within the City of Marshall, Minnesota:

All that part of the Southwest Quarter (SW $\frac{1}{4}$ ) of Section Thirty-three (33), Township One Hundred Twelve (112) North, Range Forty-one (41) West, in Lyon County, Minnesota, described as follows:

Beginning at a point on the west line of said Section 33, Township 112 North, Range 41 West, which is 2,035.3 feet north of the southwest corner of said Section 33; thence south along the west line of said Section 33 a distance of 300 feet; thence east 1,473.74 feet to the northwesterly right of way line of the Willmar & Souix Falls Railroad; thence north 19 degrees 50 minutes east and along said railroad right of way line 318.92 feet; thence west 1,581.94 feet to the place of beginning, and containing 10.52 acres, more or less, and excepting therefrom 0.52 acres right of way for Highway No. 59.

Section 2. The quantity of land embraced within the foregoing description, and bounded and described is 10 acres, more or less.

Section 3. The Common Council hereby determines (1) that the annexation will be to the best interests of the City of Marshall, Minnesota, and of the territory affected; and (2) that the territory described herein abuts upon the City and is so conditioned as properly to be subjected to city government.

Section 4. Therefore, the City of Marshall, Minnesota, hereby ordains and declares that the property hereinbefore described be and the same is hereby annexed to, and included in, the City of Marshall, Minnesota, as effectually as if it had originally been a part thereof.

Section 5. This ordinance shall be final and shall take effect and be in force from and after filing certified copy thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State, and from and after its passage and publication.
