AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VIL-LAGE OF MAYER, CARVER COUN-TY, MINNESOTA TO INCLUDE CER-TAIN LANDS.

TAIN LANDS. WHEREAS, a petition dated Sep-tember 14, 1968 requesting annexation of the territory described below was duly presented to the Council on the 14th day of September, 1968; AND WHEREAS, it appears that said petition is proper and no objec-tions have been raised during the 30 day waiting period; THE COUNCIL OF THE VILLAGE OF MAYER, CARVER COUNTY, MIN-NESOTA ORDAINS; SECTION 1. It is hereby determin-ed that the territory described below abuts upon the VILLAGE and is so conditioned as properly to be subject-ted to village government. SECTION 2. The corporate limits of the village are hereby extended to include the territory described as fol-lows:

of the vinage are increasy described as fol-lows: Commencing at a point 160 feet North and 749 feet West from the Southeast corner of the Northeast Quarter of Section 1, Township 116, Range 26, said point on the north line of the right of way of the Great Nor-thern Railroad; thence North along the west line of Haueter's Addition to the Village of Mayer, 313.3 feet; this being the point of beginning of the land hereby conveyed; thence running West 50 feet; thence South 140 feet; thence East 50 feet; thence North 140 feet to the place of beginning, slu-ated in the Southeast Quarter of the Northeast Quarter of Section 1, Town-ship 116, Range 26, and containing 16/100 of an acre; All that nart of the Southeast Quarter

Northeast Quarter of Section 1, Town-ship 116 Range 26, and containing 16/100 of an acre; And All that part of the Southeast Quarter of the Northeast Quarter of Section 1, Township 116 North, Range 26 West described as follows: Beginning at the Southwest corner of Haueter's First Addition to the Vil-lage of Mayer, Minnesota, said point being 160 feet North and 729 feet West from the Southeast corner of the Northeast Quarter of said Section 1: thence North along the West line of Haueter's First Addition, 173.3 feet; thence West parallel to the North line of Haueter's First Addition, 173.3 feet; thence West parallel to the Worth line of Haueter's First Addition, 174.9 feet; to the Northerly right of way line of the Great Northern Railway; thence East along the Northerly right of way line of said Railway, 150.0 feet; to the point of beginning and being subject to an easement over the West 10 feet thereof for public utilities. SECTION 3. The Village Clerk is hereby directed to file certified copies of this Ordinance in the office of the Commission of Municpalities, the of-tice of the Carver County Auditor and the office of the Secretary of State of the SECTION 4. Annexation shall be complete from and after the date when certified copies of this ordinance have been filed as directed in Section 3 aboye. Dated this 28th day of October, 1958.

A. C. (5) Said newspaper purports to serve the City of Waconia in the County of Carver and it has its known office of issue in the City of Waconia in said county, established and open during its regular business hours for the gathering of news, sale of advertisements and sale of subscriptions and maintained by the publisher of said newspaper or persons in his employ and subject to his direction and control during all such regular business hours and at which said newspaper is printed. (6) Said newspaper files a copy of each issue immediately with the State Historical Society, (7) Said newspaper has complied with all the foregoing conditions for at least two years preceding the day or dates of publication mentioned below. (8) Said newspaper has filed with the Secretary of State of Minnesota prior to January 1, 1966 and each January 1 thereafter an affidavit in the form prescribed by the Secretary of State and signed by the publisher of said newspaper and sworn to before a notary public stating that the newspaper is a legal newspaper.
