ORDINACE NO. 98

AN ORDINANCE OF AMEXATION

THE CITY COUNCIL OF THE CITY OF TRACY, MINNESOTA, DO ORDATH, as follows:

SECTION I. That Mary Catherine Glaser, Mauresn O'llrien and Jacklyn O'Brien, are the owners of the tracts or parcels of land lying and being in the County of Lyon and State of Minnesota, described as follows, to-wit:

> Beginning at a point on the South line of Elm Street and which point is 132.5 feet mast of the intersection of the South line of Blm Street and the East line of Third Street Bast in the City of Tracy, Minnesota, thence South and at right angles a distance of 408.2 feet to the Borth line of State Street; thence East and at right angles along the North line of State Street 140 feet to the West line of Fourth Street Bast; thence North and at right angles along the West Line of Fourth Street Bast a distance of 408.2 feet to the South Line of Elm Street; thence West and at right angles along the South line of Blm Street a distance of 140 feet to the point of beginning, and including all legal highways and streets adjoining thereto.

SECTION II. That the foregoing described property is surrounded by property now within the municipal limits of the City of Tracy, Minnesota.

SECTION III. That pursuant to and in accordance with the provision of Minnesota Statutes Section 414.03, the City Council of the City of Tracy do hereby annex to the City of Tracy, the premises above described.
