**AN ORDINANCE TO AMEND SECTION 1 OF ORDINANCE NO. 146,
ANNEXING ADJOINING LAND, TO CHANGE LEGAL DESCRIPTION
OF SAID RESERVE ANNEXED.**

The City Council of the City of Madison do ordain:

Section 1: Section 1 of Ordinance No. 146, reading as follows:

"Section 1: That the following described land adjoining the limits of the City of Madison, located in the County of Lac qui Parle, State of Minnesota, is hereby added to, taken into and made a part of the City of Madison, to-wit:

The West 100 feet of Lot Thirteen (13), Evergreen Addition to Madison, in Section Twenty-one (21), Township One Hundred Eighteen (118), Range Forty-four (44), together with the street delineated as Park Avenue and road right of way located between the West 100 feet of said lot 13 and the corporate limits of said city of Madison."

be and is hereby amended to read as follows:

Section 1: That the following described land adjoining the limits of the City of Madison, located in the County of Lac qui Parle, State of Minnesota, is hereby added to, taken into and made a part of the City of Madison, to-wit:

The West One-half (1/2) of Lot Thirteen (13), Evergreen Addition to Madison, in Section Twenty-one (21), Township One Hundred Eighteen (118), Range Forty-four (44), together with the street delineated as Park Avenue and road right of way located between the West One-half of said Lot 13 and the corporate limits of said city of Madison.

SECTION 2: This ordinance shall be in full force thirty days from and after its passage.
