AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF CLARKS GROVE TO INCLUDE CERTAIN (PLATTED) (UNPLATTED) LAND.

Whereas, a petition has been filed with the governing body of the Village of Clarks Grove, Minnesota, signed by all of the owners of the following described real estate to have such land included within the Village of Clarks Grove, Minnesota.

All that part of the $SE\frac{1}{4} SW\frac{1}{4}$ of Section 35 - T104N-R21W, which lies east of U. S. Highway No. 65; and south of the following described line: Beginning at a point on the east line of the $SE\frac{1}{4} SW\frac{1}{4}$ of said section, which point is 438.37 feet south of the northeast corner of said quarter-quarter section;

thence west 472.0 feet on a line parallel to the north line of said quarter-quarter section;

thence north 97.15 feet on a line parallel to the east line of said quarter-quarter section;

thence westerly 525.75 feet at a deflection angle of 89 degrees 37' left to the southeasterly right-of-way line of said highway right-of-way line and there terminating;

less the south 265.51 feet of said quarter-quarter section and less the following described tract:

Commencing at a point which is 15 feet east of the southeast corner of Lot 10, Block "C" of Park Addition to the Village of Clarks Grove, Freeborn County, Minnesota, which point is the southeast corner of said Block "C" of Park Addition to the Village of Clarks Grove, and which point is marked by an iron stake monument; thence 150.97 feet east to the centerline of U.S. Highway 65; thence 509.45 feet southwesterly at a deflection angle of 126°42' right along the centerline of said highway; thence 192.90 feet southeasterly at a deflection angle of 90°00' left to a point on the one-sixteenth section line which point is the point of beginning for the tract herein described and herein conveyed; thence 39.10 feet southeasterly on an extension of the last described line; thence 75 feet northeasterly at a right angle; thence 95.23 feet northwesterly at a right angle, to the one-sixteenth section line; thence southerly along the one-sixteenth section line to the point of beginning; being a tract of land in the $SE\frac{1}{4} SW\frac{1}{4}$ of Section 35 - T104N - R21W of the 5th P.M.

AND

Beginning at a point, which point is 1367.7 feet North and 1707.3 feet East from the common Section corner of Sections 35, 34 in Township 104 North of Range 21 West of the 5th P.M. and of Sections 2 and 3 in Township 103 North, of Range 21 West of the 5th P. M.; which point is at the center of State Aid Road No. 1; running thence South 33 feet, which point is the intersection of the Southerly right-or-way line

of Trunk Highway No. 1, and being 163 feet west of the intersection of the Southerly right-of-way of State Aid Road No. 1 with the center line of Trunk Highway No. 65; running thence Southeasterly along the Westerly right-of-way of Trunk Highway No. 65 for a distance of 88.5 feet; thence Southwesterly for a distance of 150 feet; thence North for a distance of 222 feet to the center line of State Aid Road No. 1; thence East along said center line for a distance of 50 feet to the place of beginning; and lying and being in the County of Freeborn and State of Minnesota.

AND

Beginning 100' East of the Northwest corner of the Southeast 1/4 of the Southwest 1/4 of Section Thirty-five, Township One Hundred Four North, Range Twenty-one West of the 5th P.M., thence South 450' thence West 100', thence South 156', thence north-easterly 463' along highway 65, thence North 222 feet, thence west to the point of beginning.

The Village of Clarks Grove does ordain:

Section 1. That the annexation will be to the best interests of Clarks Grove and to the territory affected; that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village government.

Section 2. That the property hereinbefore described be and the same is hereby annexed to, and included in the Village of Clarks Grove as effectually as if it had originally been a part thereof.

Section 3. That this ordinance shall be final and shall take effect and be in force from and after filing certified copies thereof with the Minnesota Municipal Commission, the County Auditor and the Secretary of State and from and after its passage and publication.
