ORDINANCE NO. 55

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE VILLAGE OF WILLERNIE, WASHLINGTON COUNTY, MINNESOTA, TO INCLUDE CERTAIN FLATTED AND UNPLATTED LAND NOT EXCEEDING 200 ACRES.

THE VILLAGE COUNCIL OF THE VILLAGE OF WILLERNIE, WASH, INGTON COUNTY, MINNESOTA ORDAINS:

Section 1. A Petition having been filed with the Governing body of the Village of Willernie, Minnesota, by all in number of the following described real estate to have such land included within the Village of Willernie, Minnesota:

The South Thirty (30) feet of Lot Thirty-seven (37), and all of Lots Thirty-eight (38), Thirty-nine (39), and Forty (40), Block Nine (9) of Glenmar, as surveyed and platted and now on file and of record in the office of the Register of Deeds of Washington County, Minnesota, including that portion of Beaconsfield Road, also known as County State Aid Highway No. 36, lying adjacent thereto.

Section 2. The petition is made and filed pursuant to the provisions of Subdivsion 2 of Section 414.03 of Minnesota Statutes Annotated, with notice of the petition and the petition given to the Minnesota Mucipal Commission, the Town of Lincoln and Ecard of County Commissioners of Washington County.

Section 3. A quantity of land embraced in the foregoing description does not exceed 200 acres,

Section 4. The Village Council hereby determines that the annexation will be to the best interests of the Village of Willernie, Minnesota, and of the territory affected; that the territory described herein abuts upon the Village and is so conditioned as properly to be subjected to Village government.

Section 5. The corporate limits of the Village are hereby extended to include the property described in Section 1 and the same is hereby annexed to and included in the Village as effectually as if it had originally been a part thereof, together with that portion of Beaconsfield Road also known as County State Aid Highway No. 38 lying adjacent thereto.

Section 6. The Village Clerk is hereby directed to file copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.

Section 7. This Ordinance takes effect upon its passage and publication and the filing of the copies as directed in Section 6.
