ORDINANCE NO. 269

AN ORDINANCE RELATING TO THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF ALEXANDRIA, MINNESOTA, DECLARING THE WARD TO WHICH IT SHALL BE ATTACHED AND EXTENDING THE CORPORATE LIMITS TO ENCOMPASS SAID LAND.

WHEREAS, Alexandria Developers, Inc., has filed with the City Council a petition requesting that the hereinafter described property lying in the County of Douglas and State of Minnesota, be annexed to the City of Alexandria; and further requesting that the corporate limits of the City of Alexandria be altered to include said property, and

WHEREAS, the governing body of the City of Alexandria has examined said petition and has found that Alexandria Developers, Inc., is the sole owner of said property; that said property is contiguous to the existing boundaries of the City of Alexandria; and that said land is agricultural and contains no population, and

WHEREAS, the governing body of the City of Alexandria has caused copies of said annexation petition to be sent to the Alexandria Township Board, the Douglas County Auditor, and the Minnesota Municipal Commission and that no objection to said annexation has been received from any of said parties within thirty (30) days of the date of said notification, and

WHEREAS, the governing body of the City of Alexandria, Minnesota, finds that the property set forth in said petition is so conditioned as to properly be subjected to municipal government, and further, that the governing body of the City of Alexandria finds that the annexation of said property would be in the best interests of the municipality, and the territory affected and to be annexed,

NOW, THEREFORE, the City Council of the City of Alexandria does ordain:

SECTION I. That the following described land is hereby annexed to and made a part of the municipality of the City of Alexandria, Minnesota, and the corporate limits of the City of Alexandria, Minnesota, shall be and are hereby extended to include and encompass the land and territory described as follows, to-wit:

A part of the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 17, Township 128 North, Range 37 West of the 5th P.M. and more particularly described as follows, to-wit: Beginning at the East Quarter corner of said Section 17 (also being the southeast corner of said Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$), thence West and along the quarter line 602.45 feet to the westerly line of State Aid Road No. 20; thence North 41° 12' East and along said westerly right-of-way line of Road a distance of 919.17

feet to the intersection with the East line of said Section 17; thence South 00° 15' West and along said Section line a distance of 689.36 feet to the point of beginning and containing 4.76 acres more or less.

SECTION II: All of the land and territory described in Section I above, and hereby annexed to and made a part of the City of Alexandria, Minnesota, shall be and does hereby become a part of the Second Ward of the City of Alexandria.

SECTION III: This ordinance shall take effect from and after its passage and publication, in accordance with the laws of the State of Minnesota, the Charter of the City of Alexandria, and upon the filing of this Ordinance with the Minnesota Municipal Commission, the Auditor of Douglas County, State of Minnesota, and the Secretary of State of the State of Minnesota.
